

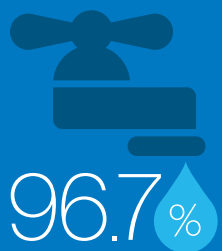

If you have Lead, Cysts, Volatile Organic Chemicals (VOCs), sediment, or chlorine tastes and odors in your water, this Watts drinking water system can provide high-quality filtration for your family.

Lead contamination in drinking water often comes from the corrosion of metal plumbing systems. Children six years old and younger are at the greatest risk, since exposure can lead to learning disabilities and behavioral problems. Even low level exposure can adversely affect brain development and lead to behavioral problems in children, premature birth and low birth weight in babies, and decreased kidney function and high blood pressure in adults.

Cysts such as *Cryptosporidium* and *Giardia* can be introduced into drinking water supplies through cross contamination with surface water, run off, and sewage. Cysts cause gastrointestinal infections.

Volatile Organic Compounds (VOCs) can originate from industrial and agricultural activity. Some are carcinogenic where others can cause organ damage.
